INTELLECTUAL DISABIILTY SERVICES	DESCRIPTION	ERIE COUNTY PROVIDERS
Agency with Choice	A service delivery option in which individuals with an Intellectual Disability/Autism and/or their family members are able to self-direct their services. This model of services encourages individuals and their advocates to be directly involved in the planning, scheduling, hiring, and management of support workers. A joint relationship is formed between an individual and/or family member with a liaison who provides administrative help to assist in managing services. The goal of this support is to enable families to remain together in their own homes. The program offers many services that individuals and families can choose from including: In Home and Community Support, Companion, Respite, Camps, and Home and Vehicle Adaptations.	• <u>Barber National Institute</u>
Behavioral Supports	Services that can be provided in instances where an individual is exhibiting behavior that is problematic for them and those they live with, and where other natural or support staff do not have an effective strategy to support the person. Support includes the services of a Behavior Specialist professional to conduct an assessment and develop a Behavior Support Plan. 	inclusion and building interest in and developing skills and potential for competitive integrative employment. Competitive integrative employment refers to full or part time work at minimum wage or higher, with wages and benefits similar to workers without disabilities performing the same work. Services are intended to flexibly wrap around or support community life secondary to employment as a primary goal. This service involves participation in activities in integrated community settings that involve persons without disabilities who are not paid or unpaid caregivers. The service is expected to result in the person developing and sustaining valued social roles and relationships, building resources and experiences in the community, increasing independence, increasing potential for employment, and experiencing meaningful community participation and inclusion. Services include assistance, support, and guidance, in the areas of self-care, health maintenance, decision making, home management, managing personal resources, communication, mobility and transportation, relationship development and socialization, personal adjustment, participating in community functions and activities, and the use of community resources.
