- * "Direct contact with students" the care, supervision, guidance or control of children <u>or</u> routine interaction with children. "Routine interaction" is regular and repeated contact that is integral to a person's employment or volunteer responsibilities.
- ^ "Direct volunteer contact with students" the care, supervision, guidance or control of children <u>and</u> routine interaction with children. "Routine interaction" is regular and repeated contact that is integral to a person's employment or volunteer responsibilities. The District includes virtual or "on-line" volunteers who have direct virtual contact with students in this category.
- ** "Guests" an individual who has been authorized to enter school property to offer a service to students, teachers or school operations but who, in their capacity as a guest, does <u>not</u> have any responsibility over the welfare of children or direct volunteer contact with children. A guest <u>may not</u> ever be left alone with student/s other than his/her own child. Examples of guests may include: individuals who enter school property to participate in one-time career presentations, large-group presentations (assemblies), large-group book readings (to entire class or grade).
- ^^ "Visitors" an individual who enters school property to visit someone, to attend a special event, or to inspect or learn more about building operations and programs but who, in their capacity as a visitor, <u>does not</u> have responsibility over the welfare or children or direct volunteer contact with children. A visitor <u>may not</u> be left alone with student/s other than his/her own child. Examples of a visitor may include: a parent attending an educational conference about his/her own child (ex: IEP meeting) or family or community members attending a school-sponsored event (ex: Halloween parade).
