



## **Erie's Public Schools Student Electronic Device Agreement**

**School Year 2025-2026**

THIS ELECTRONIC DEVICE AGREEMENT is made as of the date indicated below, by and between the School District of the City of Erie d/b/a Erie's Public Schools, referred to within as "Erie's Public Schools" or the "District", and You, as parent and/or guardian of the student identified below, and referred to within as the "Recipient" or as "You."

Whereas, Erie's Public Schools is lending the Recipient an electronic device/equipment for the purpose of facilitating remote student learning during the 2025-2026 school year; and

Whereas, the Recipient recognizes that, as a condition of receiving the electronic device/equipment, that the Recipient must covenant and promise to comply with the terms and conditions contained within this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth, and intending to be legally bound hereby Erie's Public Schools and the Recipient mutually agree as follows:

1. Erie's Public Schools will lend to You, on behalf of the Student identified below, an electronic device/equipment for the 2025-2026 school year, as is identified below, subject to and pursuant to the terms and conditions of this Agreement.
2. By accepting an electronic device/equipment from Erie's Public Schools, You are accepting responsibility for the device/equipment.
3. The electronic device/equipment issued to You, on behalf of the Student, is the property of the Erie's Public Schools. You will return the issued equipment when requested by District personnel. The District reserves the right to retrieve this equipment at any time for any reason to include, but not limited to inspection, maintenance or upgrade.
4. The electronic device/equipment may be issued in a protective case, which should not be removed by anyone other than District personnel.
5. If an issue arises with the electronic device/equipment, it should be reported immediately to District personnel.
6. You will return the device/equipment in working order to Erie's Public Schools with all issued accessories, all also in working order either at the end of the 2025-2026 school year or upon request of District personnel.
7. Students/parents/guardians may be held financially responsible for lost or damaged equipment or accessories. Degree of damage and financial responsibility will be determined by inspection of equipment at the discretion of Technology Staff, who will determine neglect or disregard versus normal wear and tear.

**8. Obligations will be attached to the student record for replacement/repair Costs as follows:**

Lost iPad — \$244	Damaged iPad — \$100 first accidental incident
Lost Chromebook - \$190	Damaged Chromebook - \$100 first accidental incident
Stolen iPad — Filing of police report and \$244	\$175 second accidental incident
Stolen iPad — no police report, full replacement cost \$294	\$250 each accidental incident after
Stolen Chromebook — Filing of police report and \$190	Lost or damaged iPad charging block \$19 and/or
Stolen Chromebook — no police report, full replacement cost \$240	charging cable \$19
	Lost or damaged Chromebook power adapter \$45
	Damaged protective iPad case — \$35

I, for myself, and on behalf of the below named Student, whom I represent as being my child or for whom I am the guardian, agree to the terms of conditions of this Agreement, and recognize that I am not obligated to agree to this Agreement, but that if I do not fully execute this Agreement, that Erie's Public Schools has no obligation to lend an electronic device/equipment for the use of the Student.
