School Improvement Goals for 25-26

- *We will focus on four main goals this year and monitor our data closely. We'll "share out" our progress at monthly PTSA meetings.
- *Students in the HMH and iReady curriculum will score 65% or higher on unit assessments.
- *Strong Vincent will have an overall regular attendance rate of 73.9%
- *Understanding the role suspension plays in overall student attendance, SV will reduce fighting incidents by 20% when compared with the previous year.
- *Parents will receive benchmark assessment data in the US mail after students complete the ELA and Math diagnostics three times per year.
- *The school-based attendance team will recognize students who have met the attendance goals quarterly.
- *We will use the Relationship Mapping Strategy to ensure every student has one caring adult at school they can go to, when needed.
